

# Privacy Policy

## Privacy Policy:

Samuel Eleyinte ("Samuel Eleyinte") operates samueleleyinte.com and may operate other websites. It is Samuel's policy to respect your privacy regarding any information we may collect while operating our websites.

## Website Visitors

Like most website operators, Samuel Eleyinte collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Samuel's purpose in collecting non-personally identifying information is to better understand how Samuel's visitors use its website. From time to time, Samuel Eleyinte may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Samuel Eleyinte also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on samueleleyinte.com blogs/sites. Samuel Eleyinte only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog/site where the comment was left.

## Gathering of Personally-Identifying

## **Information**

Certain visitors to Samuel's websites choose to interact with Samuel Eleyinte in ways that require Samuel Eleyinte to gather personally-identifying information. The amount and type of information that Samuel Eleyinte gathers depends on the nature of the interaction. For example, we ask visitors who sign up at [samueleleyinte.com](http://samueleleyinte.com) to provide a username and email address. Those who engage in transactions with Samuel Eleyinte are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, Samuel Eleyinte collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with Samuel Eleyinte. Samuel Eleyinte does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

## **Aggregated Statistics**

Samuel Eleyinte may collect statistics about the behavior of visitors to its websites. Samuel Eleyinte may display this information publicly or provide it to others. However, Samuel Eleyinte does not disclose personally-identifying information other than as described below.

## **Protection of Certain Personally-Identifying Information**

Samuel Eleyinte discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Samuel's behalf or to provide services available at Samuel's

websites, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using Samuel's websites, you consent to the transfer of such information to them. Samuel Eleyinte will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Samuel Eleyinte discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when Samuel Eleyinte believes in good faith that disclosure is reasonably necessary to protect the property or rights of Samuel Eleyinte, third parties or the public at large. If you are a registered user of an Samuel Eleyinte website and have supplied your email address, Samuel Eleyinte may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Samuel Eleyinte and our products. If you send us a request (for example via email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Samuel Eleyinte takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

## **Cookies**

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Samuel Eleyinte uses cookies to help Samuel Eleyinte identify and track visitors, their usage of Samuel Eleyinte website, and their website access preferences. Samuel Eleyinte visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Samuel's

websites, with the drawback that certain features of Samuel's websites may not function properly without the aid of cookies.

## **Business Transfers**

If Samuel Eleyinte, or substantially all of its assets, were acquired, or in the unlikely event that Samuel Eleyinte goes out of business or enters bankruptcy, user information would be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of Samuel Eleyinte may continue to use your personal information as set forth in this policy.

## **Ads**

Ads appearing on any of our websites may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by Samuel Eleyinte and does not cover the use of cookies by any advertisers.
